## - DECISION ON THE ANNULMENT OF PUBLIC PROCUREMENT PROCEDURE -

Pursuant to Article 69, paragraph 3 (Other verifiable reasons beyond control of contracting authority which could not be foreseen at the time of initiating the public procurement procedure), Art. 70, par. 1, 4 and 6 of Law on Public Procurement ("Official Gazette of BiH" number 39/14), recommendation by the person in charge of carrying out the public procedure 01-3-1252-U-7-4/19 of 10. 04. 2019, and Article 108. of Statute of University of Sarajevo, Dean of the School has made the following

# DECISION on the annulment of public procurement procedure

#### Article 1.

The procedure for public procurement of providing the antiplagiarism software service for the needs of School of Economics and Business is annulled for other verifiable reasons beyond control of contracting authority which could not be foreseen at the time of initiating the public procurement procedure (Article 69. par. 3. of Law on Public Procurement).

#### Article 2.

General Administration and Legal Affairs Office is put in charge of and authorized for implementing this decision.

### Article 3.

The decision shall be published on the web page www.efsa.unsa.ba/ef/bs/javnenabavke simultaneously with mailing it to the bidder, pursuant to Article 70., par. 6 of Law on Public Procurement.

## Article 4.

The decision enters into force on the date when it was made and is submitted to the bidder pursuant to Art. 71, par. 2 of Law on Public Procurement.

#### Statement of grounds

The public procurement procedure was initiated upon the Request for public procurement number 01-3-1252-U-7-1/19 of 11. 03. 2019 and the Decision on starting the public procurement procedure number 01-3-1252-U-7-2/19 of 28. 03. 2019.

The public procurement was carried out by means of direct agreement procedure, by sending the solicitation document number 01-3-1252-U-7-3/19 of 28. 03. 2019 to the bidder "TURNITIN, LLC", 2101 Webster St, Suite 1800, Oakland, CA 94612, USA.

The estimated value of public procurement without VAT amounts to 5,867.49 KM (in words: fivethousandeighthundredsixty-seven and 49/100 KM, i.e. 3,000.00 EUR).

The bidder named above was supposed to submit their bid by 08. 04. 2019. Since the bidder did not submit the bid by the required time, the person in charge of carrying out the public procurement gave the recommendation to the School's Dean to annul the public procurement procedure.

Further, in the procedure of assessing the carried-out procedure, Dean did not find any reasons, irregularities or oversights which could constitute grounds for non-acceptance of the recommendation of the person in charge of public procurement.

In the procedure, it was established that the person in charge of carrying out the public procurement procedure acted correctly and that the recommendation for the annulment of public procurement procedure was given in accordance with Law on Public Procurement and solicitation document.

Indeed, the procedure of the procurement in question undoubtedly established: other verifiable reasons beyond control of contracting authority, which could not be foreseen at the time of initiating the public procurement procedure, which fulfills legal requirements for the annulment of public procurement procedure.

Based on the reasons explained above, and by applying Article 69, paragraph 3, Other verifiable reasons beyond the control of contracting authority which could not be foreseen at the time of initiating public procurement procedure, of Law on Public Procurement, and Article 108. of Statute of University of Sarajevo, it was decided as stated in Article 1. of this decision.

#### INSTRUCTION OF LEGAL REMEDY:

An appeal against this Decision may be lodged, no later than 5 (five) days upon the receipt of the Decision.

The appeal is lodged to the Appeals Examining Office of Bosnia and Herzegovina, via contracting authority, in writing, directly or by registered mail to the address:
